## ANNUAL REPORT 2019 - 2020

Building on ten years of success as a research centre, the Canadian Institute for Inclusion and Citizenship (CIIC) was established by the Vice Principal - Research and Innovation at the UBC Okanagan Campus in 2019.

The CIIC was launched with a celebratory Indigenous Disability Awareness Month event at UBCO recognizing the valuable contributions that Indigenous persons living with disabilities bring to our communities.

We are Canada's first university - based research institute with a dedicated focus on social policy and practice issues concerned with the full inclusion and citizenship of people with intellectual and developmental disabilities.

# Executive Summary

The Canadian Institute for Inclusion and Citizenship is at the forefront of building Canada's capacity in the field of intellectual and developmental disabilities (I/DD) research. The CIIC operates across both the UBC Okanagan and the UBC Vancouver campuses.

The goals of the Canadian Institute for Inclusion and Citizenship are closely aligned with the *UBC Strategic Plan: Shaping UBC's New Century*. The UBC Strategic Plan Vision is: "Inspiring people, ideas and actions for a better world." The Canadian Institute for Inclusion and Citizenship envisions a society that acts to achieve lives of quality for all citizens. Importantly, the work of the Institute specifically focuses on a population of people who historically experienced and continue to experience marginalization (e.g., institutionalization, segregation, social exclusion, stigmatization, to name a few). As such, through research, learning, and knowledge exchange, the Institute will continue to inform social change by promoting practices and cultures of inclusion. We will do this by keeping central the knowledge-users of this work: self advocates, family members, community (e.g., service providers), policy makers, government, and the private sector. As our mission states, we do this to "secure justice, equality, and well-being of all citizens" believing that inclusive and diverse communities and societies benefit all people.

Furthermore, the UBC Strategic Plan's Purpose commits to pursuing excellence in research, learning and engagement to foster global citizenship and advance a sustainable and just society across British Columbia, Canada, and the world. In a similar way, the Institute works to advance the inclusion and full citizenship of individuals with I/DD and their families, and to engage in research that informs policy and practice that advances these goals provincially, nationally, and globally. Moreover, our core beliefs underscore these commitments. We believe in inclusion, citizenship, access, lifelong learning, leadership, and collaboration and partnerships.

## Directors' Message

*Rachelle Hole and Tim Stainton*

When sitting down to write our message this year, it was hard not to jump to 2020 having found ourselves in the middle of the COVID 19 pandemic that has impacted our work and those we care about. But before reflecting on the many ways we've responded to COVID 19 in our lives and in our work, there are and were many things to celebrate and mark that occurred during the 2019/2020 year. You will see from the contents of this report that, despite COVID 19, we have had a busy and productive year with numerous new projects and initiatives.

2019 marked the ten-year anniversary of the UBC Centre for Inclusion and Citizenship. It represented a time to reflect on a decade of work and the many successes that were only possible because of meaningful

partnerships with academic colleagues and community partners. It was also a time to look forward, dream, and plan for a future ten years of work together. One key outcome was set: to become a research institute at UBC. And, in May 2019, with the support of the DVC and Principal at UBC Okanagan and the Vice Principal Research and Innovation at UBC Okanagan, the UBC Okanagan Senate approved our application to become a UBC Institute at both UBC campuses.

As part of this transition, we formalized our relationships with existing research affiliates and established new connections by establishing formal research leads from both campuses: Dr. Jennifer Baumbusch, Dr. Lise Olsen, Dr. Karen Ragoonaden, & Dr. Leyton Schnellert. These researchers, along with Tim and Rachelle, lead four research streams: Policy, Practice, and Ethics; Employment and Transitions; Health and Well-being of Individuals with intellectual and developmental disabilities (IDD) and their Families Across the Lifespan; and Inclusive Education (<https://cic.arts.ubc.ca/research-streams>). In addition, while committed to attending to issues of diversity in all our work with an explicit commitment to being inclusive of Indigenous perspectives, we aim to formalize a fifth research stream committed to meaningful engagement with Indigenous communities, families, and people with IDD.

To celebrate this decade of work and partnerships and to celebrate the launch of the Institute, we gathered at UBC Okanagan in November to recognize Indigenous Disability Awareness Month in partnership with the BC Aboriginal Network on Disability Society, the Okanagan Nation Alliance, the UBC O Aboriginal Programs and Services, and the UBC Okanagan Disability Resource Centre. We also invited colleagues from across Canada to join us for discussions about establishing a national network of researchers and community partners with a goal to promote a national IDD research agenda that advances inclusion and equity for all. And, while there are many more activities and projects to celebrate, which this report highlights, we would be remiss not to reflect on the impact of COVID 19 on our lives and our work.

COVID 19 has exposed the precarity (vulnerability) of persons with intellectual and developmental disabilities and “has uncovered systems that lack policies and practices to be responsive to the needs of people with disabilities” and their families (Hole & Stainton, 2020). We want to recognize the great work of the self advocate organizations like the Self Advocate Leadership Network and our community partners who have worked to respond to the COVID 19 crisis. While our other research projects continue, researchers of the institute are involved in five COVID 19 related research projects. For example, Tim and Jennifer Baumbusch co-lead the Canadian implementation of an international survey on the impact of COVID 19 on individuals with intellectual disabilities and their families.

While COVID 19 has made life challenging for our students, we were happy to be able to provide a range of research and learning opportunities for many of them as well as opportunities to present at virtual conferences. Finally, while our connections are all virtual now, we appreciate the continued partnerships with our community partners and your contribution to the continued work of the Institute. And, of course, we want to thank Cindy Chapman, the Institute coordinator, who helps keep us on track.

## Message from the Provincial Advisory Board Chairperson

For me, it takes time to get to know someone. It's important to really trust the people in your life and stay close to the people who love you. It's important not to blame yourself and to always do your best. Often you meet people when you aren't expecting it. If you are looking for more people in your life, the best thing to do is go out there and do the things that make you happy. You never know who you might meet and where life will take you."

- Dr. Shelley Cook "Better Serving People with Multiple, Complex Needs in BC Through Health System Impact" Funding: CIHR Health Impact Post-Doc Fellow (2019 - 2021)

Dr. Shelley Cook is the recipient of the Health System Impact Fellowship from the Canadian Institute for Health Research with funding support from the Michael Smith Foundation for Health Research in BC and Community Living BC. The host partner is Community Living BC and the academic partner is UBC Okanagan.

The aim of this Health System Impact (HSI) fellowship is to better understand and address the health needs and service requirements of CLBC eligible adults who fall within the multiple, complex needs (MCN) framework. This population of people with life-long disabilities are not well served by existing services in BC, and little is known about their unique health needs/requirements. Owing to the complexity of their health and social issues, they crossover multiple services systems and are often high service users. Using a mixed methods design, the aim of this multi-phase research project is to better understand the health-related needs of this population and to identifying/learn from emerging practice within BC and Canada.





# Research Streams & Project Descriptions

## Research Streams

Four research streams inform the work of the Institute at present and we intend to add a fifth research stream focusing on promoting and conducting I/DD research with Indigenous communities and families within the next three years.

### Policy, Practice and Ethics

**Primary Lead: Dr. Tim Stainton – School of Social Work, Faculty of Arts, UBC Vancouver**

**Co-Lead: Dr. Rachelle Hole – School of Social Work, Faculty of Health and Social Development, UBC Okanagan**

This stream has a broad focus on issues concerned with policy, structures, and direct practice in the field. This encompasses both Provincial (the primary responsible jurisdiction) and National policy and practice in Canada as well as international policy and practice developments. While issues directly affecting people with I/DD and their families will be the core focus, this stream will also extend to health care practices, which may impact people with I/DD as well as global issues such as the implementation of the UN Convention on the Rights of Persons with a Disability. Dr. Stainton is ideally suited to lead this stream having been recognized for many years as one of the leading international experts in this area and having consulted with governments and organization across Canada and internationally.

### Employment and Transitions

**Primary Lead: Dr. Rachelle Hole – School of Social Work, Faculty of Health and Social Development, UBC Okanagan**

**Co-Lead: Dr. Tim Stainton – School of Social Work, Faculty of Arts, UBC Vancouver**

Employment is a key aspiration for individuals with I/DD and a key priority of the community living sector. Research demonstrates that employment enhances quality of life for most working-age adults and is a key mechanism for enhancing social inclusion. This research stream focuses on improving employment outcomes for individuals with I/DD with an additional focus on transitioning youth. Intervening early is key to improving employment outcomes for individuals with I/DD.

## **Health and Well-being of Individuals with Intellectual and Developmental Disabilities and their Families Across the Life-Course**

**Primary Lead: Dr. Jennifer Baumbusch – School of Nursing, Faculty of Applied Science, UBC Vancouver**

**Co-Lead: Dr. Lise Olsen – School of Nursing, Faculty of Health and Social Development, UBC Okanagan**

It is well documented that individuals with intellectual and developmental disabilities and their families experience health inequities across the life-course. This research cluster aims to illuminate socio-political and structural factors that contribute to inequities. This research will help to inform ethical and equitable policies and practices that support health and well-being across the life-course.

## **Inclusive Education**

**Primary Lead: Dr. Leyton Schnellert – Faculty of Education, UBC**

**Co-Lead: Dr. Karen Ragoonaden – Faculty of Education, UBC Okanagan**

The Inclusive Education research stream is comprised of university faculty, educators, self advocates, and family members deeply committed to enacting and furthering inclusive education. This research stream is comprised of people with expertise in diverse research methodologies, theoretical approaches, and educational structures, practices, and pedagogies. We seek to mobilize and generate knowledge that supports the inclusion of students with I/DD through intersectional approaches that leverage potentialities across cognitive, sensory, cultural, gender, sexual orientation, and gender identity diversities.

## **Working with Indigenous Communities and Families and I/DD**

We are committed to formalizing an explicit research stream focused on I/DD research with Indigenous communities and families in the next 3 years.

## Research Project Descriptions & Selected Highlights

### Sex, Lies and Citizenship / Romance, Relationships & Rights

Funded by the Vancouver Foundation in partnership with the Community Living Society, Anvil Centre, Massey Theatre and supported by the UBC Department of Theatre and Film and Real-Talk.

Sex, Lies & Citizenship was 3-year community-based participatory theatre project focused on improving sexual health knowledge and positive sexuality among self advocates. Building on research gathered in an earlier Sexual Health Knowledge pilot project, Sex, Lies and Citizenship conducted an additional series of interviews with self advocates. Using what was learned in the research and in collaboration, self advocate co-creators and actors used community-based participatory methods to co-create and produce a participatory theatre project. Through facilitated activities, the Company created scenes, the dialogue within them, and Romance, Relationships, and Rights was born!

The performance confronted misconceptions about adults with intellectual disabilities and challenged audiences to think differently about how we value, respect and support self-advocates' rights to romance and intimate relationships.

Undergraduate students, graduate students and theatre professionals co-facilitated the development of the theatre piece and mentored self-advocate actors and technicians. UBC student and Assistant Stage Manager Catherine McLaren noted, "this invigorating collaborative experience has shown me how accessible and adaptable theatre can and should be."



ROMANCE, RELATIONSHIPS & RIGHTS ACTORS/CO-CREATORS

### **Disrupting Misconceptions and Forging Pathways for Students with Developmental Disabilities**

Funded by UBC Community Engagement in partnership with Inclusion BC.

Increasingly students with developmental disabilities are facing discrimination and stigma in school. Extensive media attention has been given to “behaviour” of students that is deemed unsafe. Students are being excluded from classrooms and ostracized in their communities. Organizations from the United Nations to parent advocacy groups are calling for action to recognize students with developmental disabilities as full citizens with the right to education. This collaboration will create four short films raising awareness about the exclusion of students with developmental disabilities and offering key information and possible pathways to success for families and schools.

### **Microboards, Social Capital, Self Determination & Quality of Life**

Funded by Mitacs with Vela Canada and Community Living British Columbia.

Microboards are small groups of people who have agreed to collaborate with an individual with a disability to form a person-centered ‘board’. This project questioned if and how Microboards increase and individual’s social capital. The research team is presently working with UBC Studios on knowledge translation materials including an info-graphic and animated/whiteboard video.

### **Implementing Physical Activity Programs in Communities for Children with Neurodisabilities**

Funded by Michael Smith Foundation for Health Research. Implementation Science Team Grant

Few physical recreation programs exist for children with neurodevelopmental challenges, particularly in rural settings and in Indigenous communities. This project's goal is to study the implementation of a new physical activity coaching approach (NPAC) for children with neurodevelopmental challenges and their families.

### **Assessing feasibility and effectiveness of an online parent resource to support safe and active sport and recreation for children with autism spectrum disorders.**

Funded by Social Sciences and Humanities Research Council.

Focus areas include child injury prevention, promotion of physical activity for children and families, and understanding the experiences of parents who have a child living with a chronic condition or disability. A main focus is on the needs of families who have a child living with Autism Spectrum Disorder (ASD). We are aiming to learn how families can be better supported to promote their children’s health through safe and active physical activities.

### **Review of Respite Supports and Services for Children and Youth with Special Needs**

Commissioned & funded research report by the Michael Smith Foundation for Health Research on behalf of the BC Ministry of Children and Family Development to inform the new Children and Youth with Special Needs Provincial Framework. The project completed a literature review, jurisdictional scan, knowledge synthesis paper and recommendations.

### **Transitioning Youth with Disabilities and Employment (TYDE) [www.mytyde.ca](http://www.mytyde.ca)**

Funded by Social Sciences and Humanities Research Council and Canadian Institute for Health Research, and with Community and Government Partners.

This project is an interdisciplinary, cross-sectoral network of partners committed to improving the employment outcomes for transitioning youth ages 14 – 18 with intellectual disabilities or autism in British Columbia through early an intervention targeting youth and their parents/caregivers. Through this partnership, we are creating an interactive online curriculum to increase employment outcomes for youth with developmental disabilities by increasing youth pre-employment skills, increasing youth self-determination, and improving parental/caregiver knowledge and expectations for fostering their youth's future employment experiences.

## Space

### UBC Okanagan

Presently, the Canadian Institute for Inclusion and Citizenship shares space with the Institute for Community Engaged Research at UBC Okanagan. There is one office space for Dr. Rachelle Hole, three work stations, and a board room. Both Dr. Hole's office and the board room are not accessible to individuals who use wheelchairs or other mobility devices. In addition, with the award of the recent TYDE partnership grant, additional work station space is needed for staff and research assistants (RAs) of the TYDE project in addition to existing and future RAs from other projects. Other potential uses of the space based on past practices is supervising UBC Okanagan School or Social Work practicum students and providing space for a School of Social Work sessional instructor. It would be beneficial to have a new space for the Institute at UBC Okanagan to increase the profile of the Institute (to have its own identity), to address increased capacity and infrastructure needs, and to ensure that the space is accessible to those with disabilities.

## UBC Vancouver

The CIIC Coordinator is presently housed in an office at the School of Social Work in Vancouver. Work space for student trainees and work study students is limited and has been provided on an as needed basis. Meeting rooms in the Jack Bell Building are used to host public learning and knowledge exchange events as well as meetings of the Provincial Advisory Board. At this time, we do not anticipate requiring any additional space at UBC Vancouver.
